REGULAR SEASON IS MAY 1 - OCTOBER 15

MEMBERSHIPS

- NO MEMBERSHIP TRANSFERRING ALLOWED.
- ADDING OR CHANGING A SECONDARY MEMBER ON A REGULAR MEMBERSHIP APPLICATION WILL RESULT IN A \$50 FEE. THE CHANGE WILL NOT BE PROCESSED WITHOUT THE RETURN OF THE ORIGINAL GATE CARD AND THE GRAVEL PONDS MEMBERSHIP CARD. NO EXCEPTIONS!
- EACH MEMBER IS RESPONSIBLE FOR LEARNING THE LOCATIONS OF THE: FIRST AID STATIONS, AED, WATER, EMERGENCY PHONES, BEACH SAFETY EQUIPMENT, AND EMERGENCY EXITS (SEE INCLUDED MAP).
- ALL PROBLEMS OR OUESTIONS SHOULD BE REPORTED DIRECTLY TO THE PROPERTY MANAGER.
- CAMPSITES ARE ON A FIRST-COME, FIRST-SERVED BASIS, 1 SITE PER MEMBER. GRAVEL PONDS RESERVES THE RIGHT TO DOUBLE UP SITES AS NEEDED DURING ANY TIME OF THE SEASON-ESPECIALLY, DURING THE MAIN HOLIDAY WEEKENDS. NO PARKING OF UNITS AWNING TO AWNING AT ANY TIME.
- NO SAVING SPOTS FOR OTHER MEMBERS OR GUESTS.
- EXTRA VEHICLES NEED TO BE PARKED IN THE OVER-FLOW PARKING AREAS. YOU MAY NOT PARK AT AN
 EMPTY CAMPSITE.
- GUEST PASSES MAY BE PURCHASED IN ADVANCE <u>BY MEMBERS ONLY</u> –
 \$5 EACH FOR DAY PASSES & \$9 EACH FOR OVERNIGHT PASSES (HIGHER PRICING FOR SPECIAL EVENTS).
- ALL CHILDREN, AGES 18 YEARS OR OLDER (ONCE THEY ENTER GRAVEL PONDS PROPERTY), <u>ARE REQUIRED TO HAVE A GUEST PASS COMPLETED AND PUT IN THE BOX ON THE STORE PORCH OR A MEMBERSHIP.</u> HANDICAPPED CHILDREN OF MEMBERS ARE EXEMPTED FROM THIS, BUT NEED TO REQUEST FROM THE PARK MANAGER, SIGN AND HAVE ON FILE-A MEMBERSHIP WAIVER.
- GUESTS ARE NOT ALLOWED TO PARK OUTSIDE THE GATE AND WALK IN AFTER HOURS UNLESS THEY ARE ACCOMPANIED BY A MEMBER AND THEY HAVE A VALID OVER-NIGHT GUEST PASS.
- ALL MEMBERS ARE RESPONSIBLE FOR EDUCATING GUESTS IN REGARD TO PARK RULES AND MAKING SURE THE GUESTS FOLLOW ALL THE RULES.
- ANYONE NOT OBEYING PARK RULES WILL BE SUBJECT TO HAVING MEMBERSHIP REVOKED WITH NO
 REFUND.
- IF YOU LOSE YOUR MEMBERSHIP CARD, THERE WILL BE A \$2 CHARGE TO REPLACE IT.
- IF YOU CHOOSE OR GRAVEL PONDS CHOOSES TO TERMINATE YOUR MEMBERSHIP BEFORE THE END OF THE SEASON, YOUR MEMBERSHIP CARD(S) MUST BE TURNED IN OR YOUR ACCOUNT WILL BE CHARGED \$50.00 PER CARD.

PARK RULES

- 1. MANAGEMENT IS AWARE OF AND SENSITIVE TO THE RECENT DECRIMINALIZATION OF POSSESSION OF UP TO TWO (2) OUNCES OF MARIJUANA UNDER THE NEW YORK STATE LAW. MANAGEMENT IS ALSO CONCERNED ABOUT THE COMFORT AND SENSIBILITIES OF THE CAMPING COMMUNITY AT OUR FACILITY. UNTIL FURTHER WRITTEN NOTICE FROM MANAGEMENT OF GRAVEL PONDS, THE USE, POSSESSION, SALE, CONSUMPTION AND SMOKING OF MARIJUANA, MARIHUANA, HASHISH, CBD OIL AND ANY DERIVATIONS OF MARIJUANA, MARIHUANA, HASHISH OR CBD OIL IN ANY QUANTITY IS ABSOLUTELY FORBIDDEN AND PROHIBITED. UPON RECEIPT OF ANY RELIABLE COMPLAINT OF THE USE, POSSESSION, SALE, CONSUMPTION OR SMOKING OF THE SUBSTANCES LISTED ABOVE, MANAGEMENT SHALL PROMPTLY INVESTIGATE THAT COMPLAINT. IF MANAGEMENT VALIDATES THE COMPLAINT, MANAGEMENT SHALL REQUIRE THAT SUCH USE, POSSESSION, SALE, CONSUMPTION OR SMOKING SHALL CEASE IMMEDIATELY. UPON THE FIRST INSTANCE THAT MANAGEMENT CONFIRMS THAT THE ACTIVITY PROHIBITED HAS OCCURRED, THE MEMBERSHIP WILL BE TERMINATED IMMEDIATELY. ALL MEMBERS OF GRAVEL PONDS ARE REQUIRED TO ENSURE THAT THEIR FAMILY MEMBERS AND GUESTS ABIDE BY THIS RULE AND ALL OTHER RULES THAT WE HAVE AT GRAVEL PONDS.
- 2. IF NOT CAMPING, <u>THE USE OF THE SIGN-IN & SIGN-OUT LOGS IS MANDATORY</u> (LOCATED ON THE GENERAL STORE PORCH).
- 3. PARKING IN DESIGNATED AREAS ONLY-NO PARKING ON GRASS WHEN MUDDY!
- 4. THERE WILL BE <u>NO PARKING</u> OF VEHICLES ALLOWED ALONG THE ROADSIDE OF NON-ELECTRIC <u>SITES 33-35-LOADING AND UNLOADING ONLY! (LOCATED NEAR PICNIC AREA)</u>. YOU MAY PARK IN THE PARKING AREA ACROSS FROM THE STOP SIGN.
- 5. ALL THE TRAFFIC IS ONE WAY AROUND THE POND ONCE YOU PASS THE WALKING BRIDGE BEFORE, THE KIDDIE BEACH-THE SPEED LIMIT IS 5 MPH. ANYONE SPEEDING WILL BE SUBJECT TO A MANDATORY FINE AND RISK CANCELLATION OF GATE CARDS. ANYONE PARKING IN DESIGNATED SPOTS BY THE MAIN BEACH MAY EXIT THE PARK BY PASSING THE GENERAL STORE INSTEAD OF DRIVING AROUND THE POND-2 WAY TRAFFIC IS ALLOWED BETWEEN THE MAIN GATE AND 89E, JUST PAST THE DOG POND.
- ANY PERSON FOUND ABUSING OR VANDALIZING ANY PROPERTY OF GRAVEL PONDS WILL HAVE THEIR MEMBERSHIP REVOKED AND BE CHARGED FOR THE DAMAGES AS PROVIDED BY LAW.
- 7. MANAGEMENT IS NOT RESPONSIBLE FOR THEFT, LOSS, OR DAMAGE OF PROPERTY.
- 8. MEMBERS ARE RESPONSIBLE FOR CLEANING UP AFTER THEMSELVES ALL TRASH TO BE TAKEN TO THE DESIGNATED DUMPSTER.
- 9. NO ICE FISHING OR WINTER ACTIVITIES.
- 10. NO DISCHARGE OF FIREARMS. NO HUNTING OR TRAPPING.
- 11. NO CHILDREN SHOULD BE LEFT UNATTENDED. ALL CHILDREN MUST BE AT THE CAMPSITE BY DARK (NO EXCEPTIONS).
- 12. ALL CHILDREN (14 AND UNDER) MUST WEAR BICYCLE HELMETS WHILE RIDING BIKES, IT IS NYS LAW.
- 13. NO BICYCLE RIDING AFTER DARK. (ADULTS OR CHILDREN, NOT EVEN ELECTRIC).
- 14. NO BICYCLES IN FRONT OF THE STORE OR ON THE STORE DECK USE THE BIKE RACK PROVIDED.
- 15. NO SKIDDING OR SLIDING BICYCLES ON STONE ROAD.
- 16. NO LOUD OR OFFENSIVE MUSIC (NO PROFANITY). NO ILLEGAL DRUGS, NO NUDITY AND NO FOUL LANGUAGE.
- 17. NO GLASS BOTTLES.
- 18. NO STONE THROWING.
- 19. NO PLAYING ANY TYPE OF GAMES ACROSS FROM ROADWAYS.
- 20. IF YOU HAVE A CAMPER IN THE WINTER OR SUMMER STORAGE AREA, THERE IS NO PRORATING OR REFUNDS OF FEES.

- 21. CIGARETTE BUTTS MUST BE PROPERLY DISPOSED OF NOT THROWN ON THE GROUND OR IN THE WATER. NO UNDERAGE SMOKING.
- 22. NO SMOKING ON THE BEACHES, IN THE POOL AREA, WITHIN 30 FEET OF BOULDER HALL, AT THE ICE CREAM OR GRILL WINDOW, THE GENERAL STORE OR THE BEDROCK PUB & CAFÉ.
- 23. NO UNDER-AGE DRINKING.
- 24. NO UNLICENSED VEHICLES, ATV'S, MINI-BIKES, ETC NO UNLICENSED OR UNDERAGE DRIVERS.
- 25. NO WASHING OR REPAIRING OF VEHICLES.
- 26. NO RIDING ON THE OUTSIDE OF ANY MOTOR VEHICLE (HOOD, WINDOW, ROOF, BUMPER, ETC.).
- 27. NO MOTORIZED FISHING BOATS. (ELECTRIC BOAT MOTORS MAY BE USED, BUT MUST FIRST BE CLEANED, TO PREVENT UNWANTED PLANT AND ANIMAL LIFE FROM ENTERING THE POND).
- 28. ALL BOATS ARE SUPPLIED BY GRAVEL PONDS. NO PRIVATELY OWNED BOATS/KAYAKS ARE ALLOWED.
- 29. NO GOLF CARTS, MINI-BIKES, HOVERBOARDS, GAS-POWERED BIKES, SCOOTERS & ETC. DUE TO SAFETY REASONS (ONLY PERMANENT MEMBERS MAY HAVE ELECTRIC GOLF CARTS). THOSE NEEDING MOBILITY SCOOTERS ARE OKAY.
- 30. CHINESE LANTERNS ARE NOT PERMITTED TO BE LAUNCHED AT GRAVEL PONDS, DUE TO SAFETY REASONS.
- 31. NO LARGE COMMERCIAL TRUCKS ARE ALLOWED TO PARK AT THE CAMPSITE (EXAMPLE: TOW TRUCKS). YOU MUST GET PERMISSION FROM THE MANAGEMENT TO SEE WHERE YOU CAN PARK-DON'T JUST PARK AT JACK'S REPAIR SERVICE.
- 32. ANY ALTERCATIONS-SUCH AS PUSHING, SHOVING, SLAPPING, SCREAMING, THREATENING OR VULGARITIES TOWARDS ANOTHER PERSON WILL RESULT IN IMMEDIATE TERMINATION OF THE PRIMARY AND THE SECONDARY MEMBER.
- 33. IF LAW ENFORCEMENT IS CALLED TO YOUR SITE FOR OTHER THAN MEDICAL OR FIRE ISSUES, YOUR MEMBERSHIP WILL BE REVOKED AND YOU WILL BE ASKED TO LEAVE GRAVEL PONDS IMMEDIATELY.
- 34. NO CLIMBING OR PLAYING ON THE ROCKS OR BERMS AROUND THE PARK.
- 35. NO WALKING THROUGH ANY CONSTRUCTION SITES OR PROJECTS WITHOUT BEING ESCORTED BY A GRAVEL PONDS EMPLOYEE.
- 36. QUIET TIME IS 10 PM (11 PM ON MAJOR HOLIDAYS) YOU MAY STAY OUT AT YOUR CAMPFIRE AS LATE AS YOU LIKE, BUT YOUR NEIGHBORS SHOULD NOT BE ABLE TO HEAR YOU!
- 37. AS OF MAY 1, 2021-IF YOU CHOOSE OR GRAVEL PONDS CHOOSES TO TERMINATE YOUR MEMBERSHIP BEFORE THE END OF THE SEASON, YOUR MEMBERSHIP AND GATE CARD(S) MUST BE TURNED IN OR YOUR ACCOUNT WILL BE CHARGED \$50.00 PER CARD.

CAMPFIRES/FIREWOOD

- CAMPFIRES ARE ALLOWED IN DESIGNATED AREAS ONLY. FIREPITS ON WHEELS ARE NOT PERMITTED.
- NO BON FIRES CAMPFIRES ONLY.
- NO GARBAGE, CANS OR BOTTLES IN FIRE PITS. <u>ANYONE LEAVING GARBAGE IN FIRE PIT WILL HAVE THEIR GATE CARD</u>
 CANCELED.

PETS

- ALL DOGS MUST HAVE A DOG LICENSE AND A CURRENT COPY OF THE DOG'S RABIES VACCINATION CERTIFICATE
 ON FILE WITH GRAVEL PONDS THIS INCLUDES ANY DOGS VISITING WITH GUESTS.
- ALL PETS MUST BE ON A LEASH OR ROPE AT ALL TIMES, INCLUDING TIME SPENT AT YOUR SITE-ONLY
 EXCEPTIONS ARE WHEN SWIMMING IN DOG POND, AT THE DOG RUN AND WHEN THE PET IS INSIDE YOUR CAMPER
 OR CAR.
- <u>CLEAN UP AFTER YOUR PETS AROUND THE PARK, AT YOUR SITE AND AT THE DOG PARK OR RISK HAVING MEMBERSHIP REVOKED.</u>
- NO PETS ALLOWED ON THE BEACH, IN THE STORE, IN BOULDER HALL OR IN THE RESTROOMS. IF YOU HAVE LEGAL PROOF OF A SERVICE PET, THEY WILL BE ALLOWED.
- ANY DOG CREATING A NUISANCE DUE TO BARKING, ETC., WILL BE BANNED FROM THE PARK.
- ALL DOGS MUST BE 100% CONTAINED AND CONTROLLED. IF A DOG LEAVES YOUR SITE, UNATTENDED AND UNLEASHED-THE DOG MAYBE BANNED FROM GRAVEL PONDS.
- THERE IS A DOG RUN LOCATED BEHIND BOULDER HALL. YOU ARE RESPONSIBLE FOR YOUR DOG AND CLEANING
 UP AFTER YOUR DOG.
- DOGS MAY ONLY ENTER THE WATER AT THE "DOG POND", WHICH IS LOCATED ACROSS FROM SITES 50E TO 68E. PET OWNERS ARE NOT ALLOWED IN THIS AREA.

SWIMMING

- SWIMMING IS IN DESIGNATED AREAS ONLY.
- ALL RULES POSTED IN THE BEACH AND POOL AREAS MUST BE STRICTLY FOLLOWED.
- NO UNATTENDED CHILDREN UNDER THE AGE OF 18.
- NO SWIMMING UNLESS THE BEACH IS OCCUPIED BY AT LEAST 2 ADULTS OVER THE AGE OF 18. AT LEAST ONE ADULT MUST BE ON THE BEACH.
- NO SWIMMING AFTER DARK.
- NO DIVING OR SCUBA DIVING IN ANY OF THE SWIMMING AREAS.
- NO PETS ON THE BEACHES OR IN THE POOL AREA.
- NO SWIMMING IN BAD WEATHER OR TEMPERATURES BELOW 70 DEGREES (AT THE BEACHES).
- NO SWIMMING OFF PADDLE BOATS.
- IN ANY RESCUE OR MEDICAL EMERGENCY DIAL 911 FROM THE PHONE AT THE MAIN BEACH OR THE KID'S BEACH, CONTACT THE GENERAL STORE & SOUND THE EMERGENCY ALARM BUTTON, LOCATED NEAR THE FIRST AID BOX/911 PHONE.
- NO SMOKING PERMITTED ON THE BEACHES OR IN THE POOL AREA.
- DON'T DRINK ALCOHOL AND SWIM.
- INFLATABLE POOLS AT YOUR SITE MUST NOT BE UNATTENDED. THEY MUST BE EMPTIED AND PUT AWAY WHEN NOT IN USE.

- 1. HOURS ARE SUBJECT TO CHANGE. ONLY DURING DAY LIGHT.

- 3. NO ONE UNDER THE AGE OF 18 YEARS OLD IS ALLOWED IN THE SPA AT ANY GIVEN TIME! NO EXCEPTIONS!
- 4. NO FOOD OR DRINKS ARE ALLOWED IN THE POOL FENCED AREA.
- 5. NO RESERVING CHAIRS WITH TOWELS, CLOTHING, ETC.
- **6.** NO TRUCK INNER TUBES OR LARGE FLOATS. YOU MAY ONLY USE FLOATING NOODLES OR SMALL FLOATING TUBES.
- **7.** NO JUMPING.
- 8. NO DIVING.
- 9. NO HORSEPLAY.
- 10. NO FOUL LANGUAGE.

BEACH, POOL, & SPA INFORMATION

- 1. **NEVER SWIM ALONE!** A minimum of two adults, 18 years of age or older must be present whenever the swimming facility is in use with
 - At least one adult remains on the dry sand, if at a beach.
 - · At least one adult remains on the pool deck, if at the pool.
- 2. THERE IS NO SUBSTITUTE FOR ADEQUATE SUPERVISION. Children ages 16 and under must be accompanied to the bathing facility (beaches and pool area) by a parent or guardian.
- 3. IN AN EMERGENCY, NOTIFY THE GENERAL STORE (THEY WILL NOTIFY MANAGEMENT PERSONAEL) AND CONTACT HELP AS SOON AS POSSIBLE. PHONE NUMBERS ARE POSTED BY THE EMERGENCY PHONE. A free telephone is provided at this facility (at the Main Beach #1: beside the first aide kit and AED box on the front of the store wall, across from the main beach. Kiddie Beach #2: on the side of the gray building on beach front. Pool and Spa: attached to the side of the Boulder Hall building, across from the gate entrance. THERE IS AN EMERGENCY ALARM BUTTON LOCATED AT EACH LOCATION. PUSH THE RED BUTTON AND AN ALARM WILL SOUND.
- 4. ONLY USE THE BEACH/POOL/SPA FACILITY DURING THE POSTED HOURS OF OPERATION.
- 5. NO ONE UNDER THE AGE OF 18 YEARS OLD IS ALLOWED IN THE SPA AT ANY GIVEN TIME.
- 6. SWIM ONLY IN THE DESIGNATED BATHING AREA OF THE BEACH. DO NOT PASS THE BUOY'S.
- 7. THE POOL AND SPA HAVE SHALLOW WATER-THERE IS NO DIVING ALLOWED.
- 8. DON'T DRINK ALCOHOL AND SWIM.
- AT ALL TIMES, YOU MUST FOLLOW ALL OTHER RULES AND REGULATIONS THAT ARE POSTED, INCLUDING BUT NOT LIMITED TO, NO DRINKS OR FOOD OF ANY KIND IN THE POOL OR SPA AREA.
