- A SOCIAL MEMBERSHIP CAN NOT BE COMBINED WITH ANY OTHER MEMBERSHIP, PERMANENT OR REGULAR.
- IF YOU SPEND THE NIGHT IN THE PARK UNDER A PERMANENT OR REGULAR MEMBER, YOUR SOCIAL MEMBERSHIP IS VOIDED DURING THE HOURS OF 10 PM UNTIL 5:30 AM THE NEXT DAY. THE PERMANENT OR REGULAR MEMBER MUST PURCHASE YOU AN OVER-NIGHT GUEST PASS AND YOU MUST THEN FOLLOW ALL GUEST RULES AND REGULATIONS DURING THOSE TIMES.

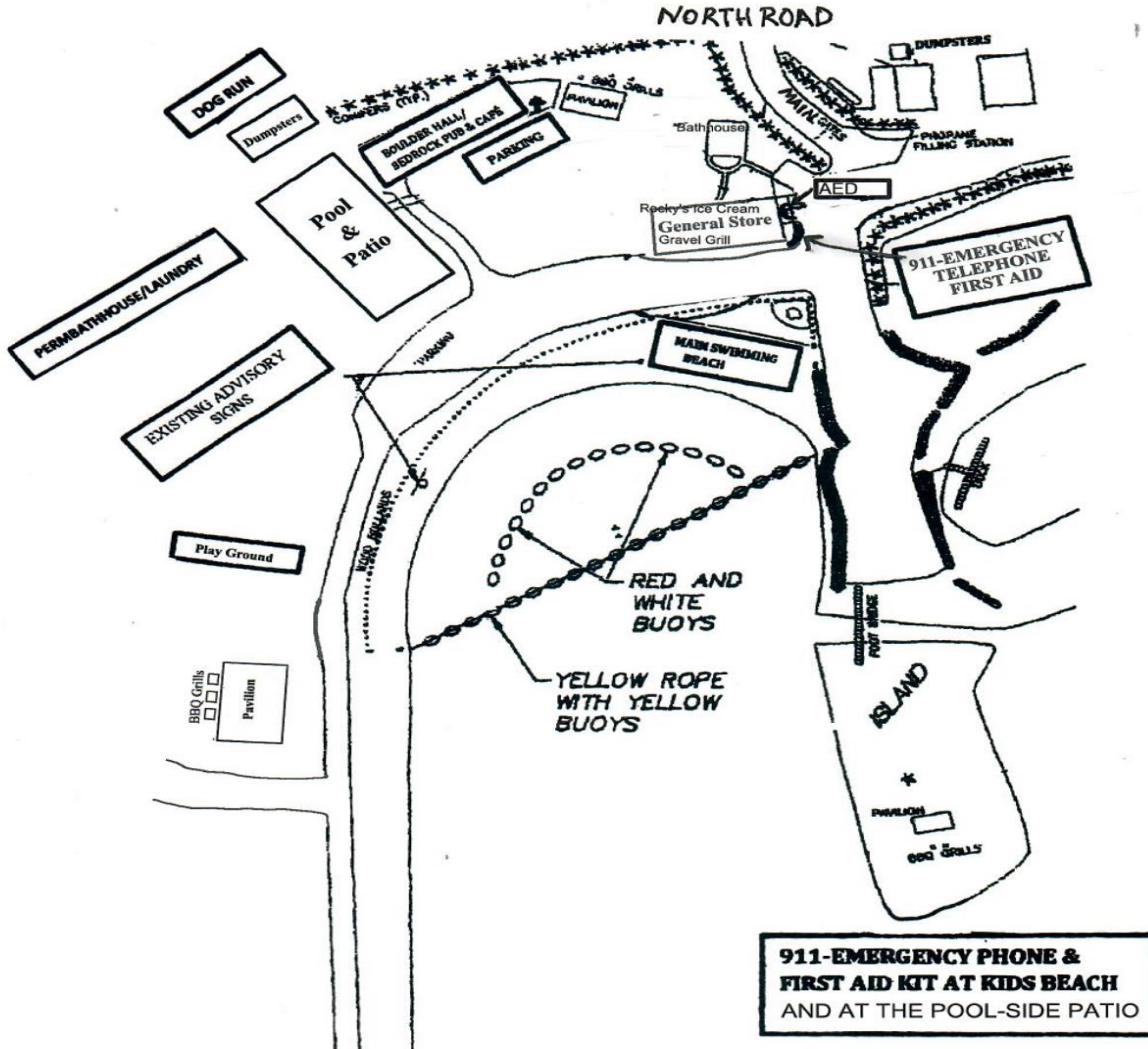
### **BEACH, POOL, & SPA INFORMATION**

2. **THERE IS NO SUBSTITUTE FOR ADEQUATE SUPERVISION.** *Children ages 16 and under must be accompanied to the bathing facility (beaches and pool area) by a parent or guardian.*
3. **IN AN EMERGENCY, NOTIFY THE GENERAL STORE (THEY WILL NOTIFY MANAGEMENT PERSONAEL) AND CONTACT HELP AS SOON AS POSSIBLE. PHONE NUMBERS ARE POSTED BY THE EMERGENCY PHONE.** *A free telephone is provided at this facility (at the Main Beach #1: beside the first aide kit and AED box on the front of the store wall, across from the main beach. Kiddie Beach #2: on the side of the gray building on beach front. Pool and Spa: attached to the side of the Boulder Hall building, across from the gate entrance. **THERE IS AN EMERGENCY ALARM BUTTON LOCATED AT EACH LOCATION. PUSH THE RED BUTTON AND AN ALARM WILL SOUND.***
4. **ONLY USE THE BEACH/POOL/SPA FACILITY DURING THE POSTED HOURS OF OPERATION.**
5. **NO ONE UNDER THE AGE OF 18 YEARS OLD IS ALLOWED IN THE SPA AT ANY GIVEN TIME.**
6. **SWIM ONLY IN THE DESIGNATED BATHING AREA OF THE BEACH. DO NOT PASS THE BUOY'S.**
7. **THE POOL AND SPA HAVE SHALLOW WATER-THERE IS NO DIVING ALLOWED.**
8. **DON'T DRINK ALCOHOL AND SWIM.**
